CONTRACTOR CRITERIA

New contractor applicants are required to meet the following criteria:

Those persons, firms, partnerships, or corporations, whether headquartered or not headquartered in the Province of Manitoba, who are engaged as contractors in the application of roofing systems and materials to sloped roof structures. (MSRA Bylaws)

1. Applicant must have been in the business of sloped roofing for a minimum of 5 years.
2. Applicant must be COR certified (Certificate of Recognition) or SECOR (Small Employer Certificate) "in good standing" or must provide suitable proof of 'Safety Certification' by an accepted 3rd party certification process/audit that supports the principles of COR & SECOR.
3. Applicant must be incorporated in the Province of Manitoba.
4. Applicant must provide proof of general liability insurance coverage at a minimum of \$2 Million in coverage.
5. Applicant must operate business from a 'commercially' zoned property in the Province of Manitoba.
6. Applicant must agree to a confidential 'credit rating' check through known suppliers. (2 references required)
7. Applicant must provide a sample copy of its 'customer contract' and any statements of consumer warranties (minimum 2 years) provided to customers.
8. Applicant must provide a listing of 3 recently installed roofs and agree to random audit review by MSRA members or designated 3rd parties.
9. Applicant will sign a declaration to adhere to the MSRA Bylaws/Code of Ethics/Policies and procedures.
10. Applicants must attend an 'Informational Meeting' with MSRA representatives prior to the completion of the application documents.
11. Successful Applicants will be subject to a formal MSRA review after one year and prior to the applicants first membership renewal. (Conducted by the MSRA Membership Committee).
